MISSION & PURPOSES – The **MAAM Foundation** exists for the purposes of promoting *magnificent aviation & aeronautical memorabilia*, through the preservation of aviation history artifacts, and through STEM education particularly as relates to aviation education & career opportunities. The MAAM Fndn is the successor charitable entity to the founding organization of the Liberal Air Museum 3+ decades ago.

MAAMBERSHIP:

Individual – personal and includes invitations to exhibits, events and periodic news of area and regional aviation activities of interest.

Family – include benefits of individual membership for all members of the same family in the same household under the age of 25.

Contributor – similar to family but also allows the contributor to designate as a give-away one Family MAAMbership as a gift; may be held by person of business.

500 Club – similar to family annually but \$500 provides for 1st year, one-time \$350 payment for support of the Foundation endowment and \$50 for '500 Club' operating and support.

GENERAL DONATIONS – these are personal and business unrestricted funds received that are used in the areas of greatest as determined by the Foundation Board of Directors.

MATCHING GIFTS – many businesses match their employee's' gifts and contributions to non-profit and charitable organizations. We encourage you to check with your employer for participation in such a program and obtain the proper form.

ENDOWMENT – designated or restricted funds the earnings of which are used for carrying out the missions of the Foundation. Also available for those interested in assistance about will, bequests, life insurance, and estate and income planning.

MEMORIALS – loss of a friend or family member is not a comforting event. But when death comes, the Foundation provides an opportunity to have a person's name memorialized in a manner appropriate to the person's interests.

VOLUNTEER – and of course, the Foundation can always use volunteer help in their various activities undertaken to achieve its mission and purposes.
